the borrowed equipment meets the needs of the intended use. Notwithstanding this, OU Walking Club would also expect that if the borrowed equipment is of a technical / mountaineering nature, which is denoted by the 'Technical?' box in the table below being initialed by the committee member, then it only be used in connection with any activity that complies fully with the rules of the British Mountaineering Council and regulations for that appropriate activity. For the borrowing of equipment for use on a Club Trip, the borrower shall undertake to be billed for the replacement cost of the equipment, should it not be returned or is returned in a noticeably worse condition. For the borrowing of equipment for use not on a Club Trip, the borrower shall give a monetary deposit matching the total valuation of the loaned equipment, as recorded below, to be kept in the storeroom of OU Walking Club throughout the duration of the loan: the deposit will be returned to the borrower when the equipment is returned to OU Walking Club in the same condition that is was loaned, but if the equipment is not returned or is returned in a noticeably worse condition then the deposit shall be retained by, and entered into the bank account of, OU Walking Club.

On signing below, the borrower accepts the following undertaking: "in accepting the equipment and signing below I, the member / borrower, confirm that I know how to operate the equipment, am aware of its limitations, and on signing this Loan Agreement accept total responsibility for its use by myself and others, and for its replacement, by my payment of a bill sent to me by OU Walking Club or by the retention by OU Walking Club of any deposit given, in the event that it is not returned to OU Walking Club in the same condition as when it was borrowed".
