MINUTES OF THE TERMLY GENERAL MEETING OF HILARY TERM 2009

Held in G&D's Café, St. Aldates, on 11th March 2009 (8th week).

Meeting declared open at 19:48 – there were 10 OUWC members in attendance. Jakub arrived at 20:11 just after the election of the Senior Member, making it 11.

1. Apologies for Absence

Trip & Safety report – the club documents that were mentioned as needing updating, were indeed updated and send to the relevant people by David Keiller.

The stores inventory was completed successfully by Jaya John.

5. Officers' Reports

President - Dave Keiller

It has been a good term, we had two weekend trips so far and there's one still to come this weekend to the Galloway Hills. Two minibus day trips happened (one was unfortunately cancelled due to the snow). The reregistration with the Proctors was completed successfully by Laura. The Annual Dinner was last weekend on 7th March, 11 people attended and it went well. We generally had one local walk per weekend this term, with usually 5-10 people turning up per walk.

We have been asked by the Proctors to amend our constitution to fit in with their rule changes, so there's a motion at this TGM to do that.

Dave thanks the committee for their work this term.

Secretary – Laura Bernstone

This term we have changed the way we book our minibuses, rather than direct with Hotson's we now email Jamie Brooks at the Sports Fed. This system has worked well so far and it seems to be more straightforward and reliable. We have had 3 new club drivers, and the club drivers list that we hold should now be fully updated and consistent with the list held by the Sports Fed.

Treasurer - Jamie Banks

Most trips have broken even this term. There are still payments to go in and out for the Galloway Hills weekend trip this coming weekend. A full accounts summary is attached to the end of the minutes.

Trip and Safety Coordinator - Jaya John John

There have been two weekend trips so far this term, to the Lakes and Snowdonia, and the Galloway Hills trip is still to come. There were two successful minibus day trips, and one to the Forest of Dean which had to be cancelled due to the snow which led to unsafe driving conditions.

Jaya John has focused on increasing the number of leaders and training this term, as we have been running low on active leaders (in MT09 we had 4 level 4 leaders, in HT09 we only had 3). He has tried to encourage level 1 leaders to lead on level 1 terrain trips such as the New Forest, as well as encouraging any potentially interested people who have been on trips. He held a training information evening to inform about the different routes to becoming a club leader, and about the available courses. He also ran a navigation and route planning evening, 3 people came to this. Two people this term have been recognised as level 2 leaders through committee approval.

There is a first aid course at the end of term, 6 OUWC members are signed up and one person will do a first aid course at a later date, he's booked on a separate course. Subsidies have been increased for ML and WGL, on a trial basis. But we hope to keep these increased subsidies up and possibly expand it in the future. Committee have agreed to add a small extra cost to trips, in order to create money for leader subsidies.

Several people are planning to take the ML course in Easter (2) or Summer (4) as well as 2 other possible people at a later date – Jaya John presented the best options after researching the different available courses. We therefore expect several new leaders to come through soon, so overall it's quite encouraging!

Membership Secretary - Helen Jenks

We had 138 members at the last TGM in MT08, and we have 167 now, so there were 29 new members this term.

Alumni Secretary - Nicolas Delerue

Archivist - Cristina Fernandez

Sixteen walks were planned this term but some had to be cancelled due to a lack of leaders, so for next term we're planning one per weekend to avoid these cancellations. This will mean it's easier for us to advertise the walks as definitely going ahead.

Quartermaster - Matt Thomas

Matt bought some new waterproofs which have come in useful as we've had trips running on the same weekend where lots of waterproofs were needed. Dave is buying several new map cases soon to replace those that are worn out. Matt also bought maps to replace those that are out of date or missing. The technical inspection with Neil Champion went fine, all of our equipment passed, and he sent his report today.

Social Rep - vacant

Webmaster – Christopher Thomas

Christopher has basically just been keeping the website up to date and has also done a bit of tidying up – we all agree that it now looks a lot better and is easier to navigate. Laura and Christopher had an interesting time dealing with OUCS, attempting to register him for OUCS access through a green form, but they eventually succeeded (although this won't be possible from MT09 due to a change in policy!).
